DRIVER'S SAFETY COURSE:

MUST ENTER A PLEA IN WRITING OF NOLO CONTENDRE OR GUILTY.
MUST CONTACT COURT TO REQUEST DSC PAPERWORK.
MUST PAY FEE OF \$108.00.
MUST HAVE A VALID TEXAS DRIVER'S LICENSE.
MUST NOT BE EXCEEDING SPEED LIMIT BY MORE THAN 24 MPH.
MUST NOT HAVE COMPLETED A DSC IN THE 12 MONTHS PRECEEDING CITATION DATE.

THIS IS NOT AN OPTION FOR CDL LICENSES.

DEFERRAL:

WILL NOT APPEAR ON YOUR RECORD.
MUST CONTACT THE COURT FOR PRICE.

THIS IS NOT AN OPTION FOR CDL LICENSES.

IF YOU FAIL TO RESPOND TO THE COURT BY THE APPEARANCE DATE SHOWN ON THE CITATION, EITHER IN PERSON OR BY PHONE, AN ADDITIONAL CHARGE WILL BE FILED AGAINST YOU FOR VIOLATING YOUR WRITTEN PROMISE TO APPEAR, AND A WARRANT WILL BE ISSUED FOR YOUR ARREST. A \$50.00 WARRANT FEE WILL BE ADDED FOR EACH VIOLATION ON YOUR CITATION. YOUR DRIVER'S LICENSE AND/OR RENEWAL OF REGISTRATION WILL BE SUBMITTED TO THE STATE FOR NONRENEWAL AND/OR SUSPENSION.
